We are pleased to inform you that, the application by the Zimbabwe East Union Conference of the Seventh Day Adventist Church, to register the Great Heights University was approved by the Zimbabwe Council for Higher Education (ZIMCHE). The approval is in accordance with the ZIMCHE Act [Chapter 25:27] Sections 10 to 11.

The Great Heights University is hereby granted a Provisional Registration valid for one year (12 months) from the date of issue, 14th August 2025 to the 15th August 2026. Besides this letter, the ZIMCHE is issuing the Great Heights University a provisional registration certificate. The Provisional Registration authorises the Great Heights University to:

- (a) Set up a governing body for the proposed higher education institution;
- (b) Commence or continue to develop physical facilities;
- (c) Commence or continue to assemble academic resources; and
- (d) Submit academic programmes the institution intends to offer for consideration and approval by the ZIMCHE.

Please note that, the institution shall only recruit students after specific approval by the ZIMCHE to do so.

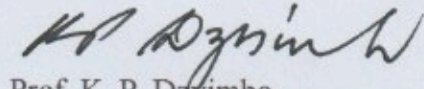
On or before the expiry of the Provisional Registration licence, the Great Heights University shall apply to the ZIMCHE for final registration by submitting to the Chief
